NOTICE TO COMPETITORS – GENERAL INFORMATION

- 🐾 The trial is being held under the rules and provisions of the Agility Association of Canada (AAC) and is open to all four (4)-legged dogs at least 18 months of age and registered with AAC by having a Dog Identification Number.
- 🐾 Dogs less than 18 months of age, bitches in season (BIS) or advanced pregnancy, dogs suffering from injury or illness that affects the dog's physical or mental performance, and any dog that demonstrates signs of aggression toward people or other dogs will NOT be permitted to participate in the trial.
- 🐾 Entry into the trial is online through Agility Rocks with payment via PayPal, eTransfer or cheque.
- 🐾 Entry into the trial shall constitute acceptance of the Cruisin' Paws Agility Trial Participation and Release Waiver, and the provisions in this Premium.
- 🐾 **Entry into the trial is first come, first served** – refer to the Trials page on our website for details on how entries will be handled in the event the trial fills before the trial closing date.
- 🐾 No food, toys or training aides are permitted on course during the walk throughs and qualification runs.
- 🐾 Dogs must be on leash in the crating area and the agility arena, unless using the warm up jumps or in the ring.
- 🐾 For Exhibition Only (FEO) runs may be allowed at the discretion of the Trial Secretary, provided the dog is not also competing in the same class for qualification.
 - Toys allowed in FEO runs. **NO FOOD** allowed in FEO runs, even if in sealed container or inside toys.
- 🐾 Cruisin' Paws Agility reserves the right to refuse any entry.
- 🐾 Entry form must be received and accompanied by the proper fees to be valid. Entry may be invalidated if payment not received within 7 days of submitting the form.

RIBBONS & TITLES

- 🐾 Rosettes & Ribbons will be available between events as time permits.
- 🐾 Placement Ribbons for 1st through 4th place will be awarded for each height in each class.
- 🐾 Qualifying Rosettes will be awarded for achieving an AAC qualifying score.
- 🐾 Title Ribbons will be attached to Qualifying Rosettes for all titles earned.
- 🐾 Special Rosettes will be awarded for ATChC and post-ATChC titles.
- 🐾 **NOTE:** It is the responsibility of the competitor to advise the Ribbons Official if a title has been achieved.

MOVE UPS

- 🐾 Move ups will be allowed before and during the trial provided the Trial Secretary is notified **before** the course walk through of the event begins. Move-up forms will be available at the trial.

REFUNDS

- 🐾 Refunds will be granted up to the trial closing date.
- 🐾 After the trial closing date, refunds will be at the discretion of the Trial Secretary.
- 🐾 No refunds for competitors dismissed from the trial.
- 🐾 Refunds where payments were made by PayPal will be refunded via PayPal. All other refunds will be made by cheque.

CONFIRMATIONS

- 🐾 Individual confirmations will be emailed for all accepted entries.
- 🐾 Group confirmations will be posted on the Trials page of our website closer to the trial date.

FACILITIES

- 🐾 One ring, indoor, on artificial turf.
- 🐾 A tarp or mat **MUST** be placed under all chairs in the seating area of the arena (all areas outside the agility ring).
- 🐾 Handlers must clean up after their dogs in the crating area, the agility arena and everywhere else on the grounds.
- 🐾 Only clean, non-marking shoes to be worn in the agility arena.
- 🐾 **No crating in the agility arena.** A separate, heated crating area adjacent to the arena is available.

FOOD

- 🐾 Cruisin' Café will be operating during the trial. Menu and pricing will be posted on the website closer to the trial.

ACCOMMODATIONS

- 🐾 A link to pet friendly hotels in London is included on our website. If you prefer, go to www.hotelsone.com and search London.
- 🐾 **Campers and Motor Homes:** A limited number of non-serviced spaces for campers or motor homes is available at trial site. Spaces must be reserved in advance through the Trial Secretary. Property gates are closed at 9pm each night. Use of trial site for campers or motor homes is at your own risk and property owners accept no liability for those using campers or motor homes during the trial.
